Thank you for joining the Association for the educational and recreational use of the 1793 Middlesex Canal. The Canal was the first part of the water highway between Boston Harbor and Concord, NH. Its efficient transportation made competitive the American System of cloth manufacture powered by the waterfalls of the Merrimack.

The certificate of your election as a proprietor has the portraits of James Sullivan, promoter and first president of the canal, and Loammi Baldwin, builder and first vice president, leading examples of the proprietors who in 1793 subscribed to digging a canal $3\frac{1}{2}$ x 30 x 27 miles with 8 aqueducts, twenty locks, and fifty bridges in ten years. We of the present generation of proprietors are strengthened by their can do example in the ninth year of building a museum/visitor center on the site of the 1794 groundbreaking. We proprietors have worked on the canal "for the benefit of the present & all Future generations" as prayed Loammi at the groundbreaking 239 years ago.


